Since 2008 Wilma Lively has served as Executive Director of DaySpring Villa Women and Children's Shelter, Oklahoma's first faith-based, certified domestic violence

and human sex trafficking shelter in Oklahoma. She is responsible for the day-to-day operations of the shelter which can house up to 55 women and their children seeking refuge from an abusive situation.

During her tenure at Day-Spring Villa Lively has worked tirelessly to bring statewide at-

tention to the growing problem of domestic abuse and its effects on families and communities throughout Oklahoma. She is a popular guest speaker on the subject of domestic violence at companies, churches, and organizations throughout the state. She is also recognized for leading DaySpring Villa to achieve the first certification of any domestic violence shelter in Oklahoma to respond to adult victims of human sex trafficking.

> Ms. Lively was appointed by Attorney General E. Scott Pruitt in August of 2013 to serve on the Office of the Attorney General's Domestic Violence and Sexual Assault Advisory Council.

Previous to her appointment as executive director, Ms. Lively served on DaySpring Villa's

board of directors. She began her affiliation with the shelter as a volunteer in 1995. She is the mother of two and has seven grandchildren.

## Catherine's Rose Geranium Cake

Wash and pat dry six medium rose-geranium leaves. Arrange them (de-stemmed) on the bottom of heavily greased and floured Bundt pan (pretty side out).

Prepare a Duncan Hines Deluxe Yellow Cake Mix batter, mixing the ingredients exactly according to directions on the box. Pour batter into Bundt pan. Bake as directed.

While cake is baking, sift 1 cup of powdered sugar (maybe more) into mixing bowl. Add enough juice of one lemon to make it syrupy.

Drizzle the powdered sugar lemon mixture over the cake while it is slightly warm. Decorate with pink begonia blossoms that have been washed and drained. Enjoy.



## **Notes from AAUW**

"No one should have to go through what I've gone through. No one. Working with AAUW, I have managed to turn my anger into action."

—AAUW member Kerri Sleeman of Michigan testifying in support of the Paycheck Fairness Act before a U.S. Senate committee

The Senate Committee on Health, Education, Labor, and Pensions held a hearing on the Paycheck Fairness Act (PFA) in April and invited AAUW member Kerri Sleeman of Michigan to testify about her experience with pay discrimination. After the company she worked for went bankrupt, Sleeman found that she was making less than some of the men she supervised. "If the Paycheck Fairness Act had been the law, I would have talked about my salary without fear, and I likely would have known where I stood in comparison to the men I worked with and those I supervised," she said.

Five months later AAUW succeeded in bringing up PFA for consideration in the Senate, and the Senate voted (73-25) to move forward with a debate on the Act. Five days later, some of those senators decided to block the bill from moving to a final up-or-down vote!
