We are pleased to welcome Dr. Pauline Harris as our guest speaker for November! In addition to being the Title IX Coordinator for TPS and owning a consultant's business, Dr. Harris is professor of African-American history, American/World History, economics, marketing, and strategic resources management. She teaches at Tulsa Community College, Southern Nazarene University-Tulsa, and Langston University-Oklahoma City.

Dr. Harris is the former Coordinator of Diversity Education at Oklahoma State University. She was instrumental in TPS receiving the 2014 and 2015 Mosaic Inclusive Workplace Culture award. Dr. Harris is a recipient of the YWCA'S 2015 Inau-

gural "Ten Women of the Year" award; she is a longtime member of the North Tulsa Historical Society.

Dr. Harris received her doctorate and master's degree from OSU; her B.S. is from Pittsburg State University. Her research includes an oral history study on the generational stories surrounding Tulsa's 1921 Race Riot.

Parsons talks about a report released in 2016 by Peterson Institute for International Economics. Their research discovered that "companies with at least 30% female leaders in senior management had net profit margins up to 6 percentage points higher than companies with no women in senior leadership. This converts to a 15% increase in profitability for a typical company."

#### **Gender Pay Gap for Latinas**

Thursday, November 2, marked Latinas' Equal Pay Day, the symbolic day when Hispanic and Latina women's earnings "catch up" to non-Hispanic white men's earnings from the previous year. Latinas are paid 54 percent of what non-Hispanic white men are paid. That means it takes Latinas almost an entire extra year of full-time, year-round work in order to be paid what the average non-Hispanic white man took home by December 31.

Urge your members of Congress to support the passage of the Paycheck Fairness Act and the Fair Pay Act.

## 12 Stats on Gender Equity That Are Scarier than Halloween!

- → Research indicates it could be 102 years before women are paid as much as men.
- → In 2017, states passed 57 new abortion restrictions.
- → Only 60 % of eligible voters cast their ballots in 2016.
- → Around 50 million workers do not have paid sick leave.

- One in five women is a target of sexual assault while in college.
- → Women make up just 12 % of the engineering workforce, and women in computing has fallen from 35% in 1990 to just 26% today.
- → The United States is the only industrialized nation that doesn't mandate paid parental leave.
- → Latinas were paid 54 cents for every \$1 paid to a white man in 2016.
- → Only 32 Fortune 500 companies are led by women.
- → Women and men don't have equal rights under the U.S. Constitution; we need to pass the Equal Rights Amendment
- → Women hold nearly two-thirds of the country's \$1.3 trillion student debt.
- → The U.S. House of Representatives has voted to repeal or alter the Affordable Care Act more than 60 times.

These statistics are a call to continued activism on behalf of women and girls!



## **Know Your Rights: Workplace Sexual Harassment**

Sexual harassment is a form of sex discrimination that violates Title VII of the Civil Rights Act of 1964. Title VII is a federal law that prohibits discrimination in employment on the basis of sex, race, color, national origin, and religion, and it applies to employers with 15 or more employees, including federal, state, and local governments. Even with Title VII's protections, many people across the country still face sexual harassment in their workplaces.

### Title IX:

### What is it, and why does AAUW care?

Title IX, which AAUW helped to craft and pass in 1972, is a federal law that prohibits sex discrimination against students and employees at educational institutions that receive federal funds:

No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving federal financial assistance.

Staff and students in any educational institution that receives federal financial assistance, including local public school districts, colleges and universities, for-profit schools, libraries, museums, and education agencies. Although Title IX is most famous for its effect on athletics, the law prohibits gender discrimination in all aspects of education. For example, sexual assault, sexual harassment, bullying based on sex, and pregnancy discrimination can be Title IX violations.

#### AAUW'S INTEREST IN TITLE IX

AAUW is in a campaign to protect Title IX and our efforts to make schools safer and more equitable for all students.

Our Legal Advocacy Fund provides case support to protect legal rights in schools and workplaces, creates precedents to combat future injustices, and holds those who violate Title IX accountable.

AAUW also aims to attract more girls and women to science, technology, engineering, and math (STEM) fields, which produce some of the fastest-growing and best-paid jobs. Our efforts need full enforcement of Title IX to succeed.

Title IX is a civil rights issue!

## AAUW CEO BLASTS SEC. DEVOS CHANGES TO TITLE IX

Secretary of Education Betsy DeVos recently announced opening up Title IX for changes. AAUW's CEO Kim Churches called this "a blatant attempt to roll back protections for students...an action that is at direct odds with upholding the civil rights of all Americans."

Churches also stated, "Considering that 89 percent of college campuses disclosed zero reported rapes last year — despite the fact that we know incidents are far more frequent — we should move forward and build on past progress, not walk back current protections."

Kim Churches added, "The American Association of University Women stands with survivors and remains committed to protecting and defending Title IX, and to pursuing its vigorous enforcement."



## STAND UP FOR EQUITY IN EDUCATION

Congresswoman Patsy Mink (D-HI) forever changed the face of academia and athletics through the passage of Title IX in 1972. Yet, inequities and barriers remain.

Now Congress can further ensure equity in education by enacting the <u>Patsy T. Mink Gender Equity in Education Act of 2017 (GEEA)</u>. Building on the legacy of Rep. Mink, GEEA would:

- Establish an Office of Gender Equity in the U.S. Department of Education to coordinate activities within the Department and among other federal agencies;
- Support the work of thousands of Title IX coordinators by providing annual training and technical assistance;
- ◆ Authorize competitive grants to K-12 schools, colleges, local educational agencies, or states to support their gender equity work.

Urge your members of Congress to co-sponsor GEEA now.
