# **Anita Hill to receive Sankofa Freedom Award**

SATURDAY, FEB. 15 10 A.M.—12:00 P.M. RUDISILL REGIONAL LIBRARY 1520 N. HARTFORD

Anita Hill, native Oklahoman attorney, author, educator and advocate for civil and women's rights, will receive the 2020 Sankofa Freedom Award, presented by the Tulsa City-County Library's African-American Resource Center and the Tulsa Library Trust.

The award, which consists of a \$10,000 cash prize and engraved plaque, is given biennially to a nationally acclaimed individual who has dedicated his/her life to educating and improving the greater African-American community.

**Since receiving** her juris doctorate from Yale Law School in 1980, Hill has taken passionate, purposeful steps toward eliminating inequality, and has spent decades advocating for gender and racial equality in financial and educational opportunities as well as in the workplace. In all her endeavors, Hill has marked herself as a voice for those who are unable or unwilling to speak out against oppression and misconduct.

Hill is the author of her 1998 memoir *Speaking Truth to Power* and the 2012 *Reimagining Equality: Stories of Gender, Race and Finding Home.* She co-edited the 1995 *Race, Gender and Power in America: The Legacy of the Hill-Thomas Hearings.* Her story is told in the 2013 documentary film *Anita: Speaking Truth to Power.*

As we head into February (African American History Month), we acknowledge the many contributions that Black Americans have accomplished for this country.


It is imperative that schools vigorously educate our young people on the history and culture of African Americans for a more equal understanding and the dynamics involved in their development and success in our society.

## The State(s) of Equal Pay Laws

For years, state legislators have been making steady strides toward enacting equity laws. In all, 49 states, the District of Columbia and Puerto Rico now have some form of equal-pay measure in place. (Mississippi is the lone holdout.)

With the help of AAUW members' advocacy, last year, 11 states passed some form of fair-pay legislation, compared with six in 2018, 2017, 2016 and 2015. Of course, we need to keep pushing in 2020 to strengthen state and local laws.







In December, the bipartisan Building Blocks of STEM Act was signed into law, with a little help from AAUW Lobby Corps. The legislation expands educational opportunities in math and science for young women and students of color. Thanks to Nevada Senator Jacky Rosen for championing the bill!

# The Top Ten Ways AAUW made the world better for women in 2019

AAUW CEO Kim Churches and Board Chair Julia Brown have sent their appreciation for the "extraordinary involvement of our members and supporters, who give us the insights, inspiration and resources to move forward with our ambitious agenda of making the world better for women and girls."

Here are the top ten ways we make that happen:

1. We trained more women to 'Work Smart'. Thanks to a \$500,000 grant from The Coca-Cola Foundation, we trained more than 102,000 women in salary negotiation skills with our Work Smart and Start Smart programs.

- 2. We advocated for equity in our nation's capital. AAUW successfully led the effort to pass the Paycheck Fairness Act in the House; we delivered testimony to Congressional committees on the Equal Rights Amendment, LGBTQ antidiscrimination protections and paid family leave.
- We helped strengthen state laws. Eleven states passed legislation in this area this year.
- 4. We championed the next generation of women. CEO Kim Churches spoke at the 2019 NCCWSL, attended by 800 young women from 307 colleges and universities.
- We empowered women leaders. The Coca-Cola grant also enabled us to implement Empower, our new leadership development and networking event
- 6. We've done groundbreaking research. We updated our study, The Simple Truth About the Gender Pay Gap, and our research Deeper in Debt. We released a new report, Limiting Our Livelihoods: The Cumulative Impact of Sexual Harassment on Women's Careers.
- 7. We spread our message far and wide. AAUW's work was covered by more than 140 media outlets; we raised our profile on social media platforms.
- 8. We provided millions in fellowships and grants. AAUW remains one of the world's leading supporters exclusively for graduate women's education, awarding \$4.3 million to 270 recipients.
- 9. We've raised funds to advance our mission. AAUW is grateful for the generous support of our members and AAUW branches. In addition, we have partnered with corporations, foundations and groups that provide invaluable support.
- 10. We prepared for 2020 a pivotal year for women. In lieu of a national convention the 2020 convening series will include webinars hosted by Kim Churches. We are gathering information from members which will go into AAUW's archives, called "Your Story. Our Legacy." We will commemorate the 100th anniversary of the 19th Amendment and the 55th anniversary of the Voting Rights Act by launching a project called "Every Voice. Every Vote."

## Virginia votes to ratify the Equal Right Amendment

The state of Virginia made history on Wednesday, January 15, 2020 by becoming the 38th state to ratify the Equal Rights Amendment.

Now our energy needs to be directed to putting strong pressure to approve the legislation in Congress to remove the original deadline assigned to the ERA. Citizens are asked to contact our congress people to urge them to sign on as a co-sponsor of H.J. Res 79 in the House of Representatives, and S.J. Res 6 in the Senate.

The update on co-sponsors of the bills is as follows:

**H.J. Res 79** (House of Representatives) = 224 co-sponsors

**S.J. Res 6** (Senate) = 41 co-sponsors (Oklahoma is not on the list of co-sponsors)

### **Equal Rights Amendment**

"Equality of Rights under the law shall not be denied or abridged by the United States or by any state on account of sex."

#### **ERA Coalition**

The ERA Coalition has issued a statement welcoming the legal action of the Attorney Generals of Virginia, Illinois, and Nevada. The final three states to ratify the Equal Rights Amendment, Virginia, #38, Illinois, #37 and Nevada, #36, filed suit February 3rd against Archivist David Ferriero, demanding he certify the ratification of the amendment.

It is time for equality. We have waited too long already for equal rights, and it is shameful that there are those who would have us wait a moment longer. We have been on the ERA journey for almost a century.

Alice Paul's idea to prohibit discrimination based on sex was a good idea in 1923 when it was first introduced in Congress. It was a good idea when it was passed by Congress in 1972. And it was still a good idea when it was ratified by Nevada in 2017, Illinois in 2018 and Virginia on January 27, 2020.


The ERA is as American as apple pie, and ERA Coalition polling indicates says that 94 percent of Americans—99 percent of millennials—agree that the Constitution should be amended to

include equal rights for women.

We need the ERA because 80 percent of our poor are women, trying to house and feed children; women are still woefully behind in pay and promotion, and inequality is a life or death issue on a daily basis as women in the home and workplace continue to fear sexual and physical assault with no recourse to federal courts because without the ERA there is no basis for such jurisdiction.

Women were intentionally omitted from the Constitution when it was written, despite the fervent plea of Abigail Adams for our inclusion.

The ERA Coalition was founded in 2014 to bring concerted, organized action to the effort to ratify the Equal Right Amendment. Comprised of nearly one hundred organizations across the country, the Coalition provides education and advocacy on Constitutional Equality. AAUW is one of the Lead Organizations of The ERA Coalition. Ratification of The Equal Rights Amendment is part of AAUW's 2020 gender policy agenda.

## Tulsa Chautaugua bringing Carrie Chapman Catt to Rally

We are excited to see Carrie Chapman Catt at the 19th Amendment Rally & March on February 22nd, thanks to the Tulsa Chautauqua. She will be a welcome addition to suffragists Elizabeth Cady Stanton, Susan B. Anthony and Ida B. Wells.

Carrie Chapman Catt, suffragist and peace activist, helped secure for American women the right to vote. She directed the National American Woman Suffrage Association and founded the League of Women Voters to bring women into the political mainstream. After the horrors of World War I, she organized the Committee on the Cause and Cure of War (1925). Concerned about Hitler's growing power, she worked on behalf of German Jewish refugees and was awarded the American Hebrew Medal (1933).
